

## **A Better Way to Talk About Health Care in 2022: Americans deserve USA Health Care: Universal, Simple, Affordable**

### **Context**

#### ***Introduction***

Most Americans realize that our health care “system” needs improvement. We all suffer because our health care is:

- NOT Universal
- NOT Simple
- NOT Affordable

In other words, American health care is not USA

#### ***What does USA mean?***

##### **Universal**

- Everyone included at all times
- All necessary services
- Freedom of choice on where to get care

##### **Simple**

- User-friendly and transparent
- Understandable paperwork and bills
- Better communication among providers

##### **Affordable**

- Fair prices, no price-gouging
- No financial barriers to care
- Eliminate high deductible insurance “products”

## *How USA fits together*

To make health care affordable, we must make it universal and simple.

Americans spend twice as much on health care as citizens of other prosperous nations. Health care makes up nearly one-fifth of our economy, which is more than enough to support Universal, Simple, and Affordable care without an increase in taxes. *We need to spend health care dollars more wisely and introduce a fairer system of funding.*

## *USA is compatible with a variety of policy proposals*

A wonderful thing about the Universal, Simple, and Affordable triad is it fits with many different policy approaches. USA is a yard stick with which to measure our progress. Whatever we do should move us closer to Universal, Simple, and Affordable.

## *Why has Universal, Simple, and Affordable care been so hard to achieve?*

The political and economic power of those who financially benefit from high prices and complex systems and a fear of change, powered by those prospering from the current system.

## **Opinion Poll Findings demonstrating the popularity of USA**

### *Universal Simple Affordable Health Care*

- **70%** think healthcare should be universal
- **95%** think it should be simple
- **99%** think it should be affordable
- **87%** think USA is a useful way to talk about health care
- **80%** think making health care Universal, Simple, and Affordable would help their families.

***Money and Health Care (less frequent answers omitted)***

- **70%** think the US can afford to provide high quality healthcare for all
- **70%** think the way we currently fund health care is poor or awful

***Freedom and Health Care (less frequent answers omitted)***

- **50%** want the freedom to make life decisions without worries about losing coverage or facing bankruptcy
- **28%** want the freedom to choose doctors and clinicians they trust

***Barriers to Change (less frequent answers omitted)***

- **56%** fear paying more and/or getting less
- **30%** see the political and economic power of for-profit companies and professional associations as the biggest barrier to change
